

Dr Sina Beiraghi – Billing Policy

Effective from 9 July 2026

Dr Beiraghi is a privately billing doctor.

Medicare rebates are available for eligible patients and are determined by Medicare based on the length and type of consultation.

Bulk billing is available for:

- Children under 16 years of age (in-person consultations only)
- DVA Gold Card holders (in-person consultations only)

All telephone consultations are privately billed at the same rate as in-person consultations. For patients who are not registered with Dr Beiraghi under MyMedicare, **Medicare limits the rebate for telephone consultations to a maximum of \$45.05**, regardless of consultation length. This means there may be a higher out-of-pocket cost for these appointments.

If you are unsure about your eligibility or expected fees, please speak with our reception team prior to your appointment.

- WorkCover consultations must be paid in full prior to claim acceptance. Once a WorkCover claim number is approved and active, billing may occur directly to WorkCover
- **Commercial driver's licence and employment medicals are not eligible for Medicare rebates.** These must be booked as long consultations. Please contact reception when booking so appropriate nurse time can be scheduled for any required testing or physical measurements.
- **Insurance medicals and insurance-related paperwork** are individually priced and **not eligible for Medicare rebates.** Please contact reception directly for an individualised quote.
